Government in G.O Ms NO: 100, Finance [DCM-III] Department, Dated: 22/04/2013 has issued orders lifting ban on transfers to the employees working in the State. The Higher Education Department has also issued guidelines with regard to transfers to the employees working in the Department of Intermediate Education

Basing on above said orders, the undersigned while communicating guidelines has formulated a time schedule in respect of the Principals of Government Junior Colleges for effecting transfers by way of counseling in a fair & transparent manner

Accordingly the time schedule for counseling has been communicated. The ravailable vacancies were displayed. Accordingly counseling in respect of Principals of Government Junior Colleges in Zone- V, VI and City Cadre has been held in the meeting hall, O/o the CIE at Hyderabad on 04.05.2013 (After noon) and for the remaining Zones, counseling was conducted at their respective RJDIE offices. The individuals have attended the counseling and have opted for certain places

Accordingly, the Principals of Government Junior Colleges in Zone as shown in Annexure- I who have completed more than 05 years of stay in the present station are hereby transferred compulsorily. All these Principals are posted to Government Junior Colleges as noted against their names in the Annexure- I. Similarly Principals of Government Junior Colleges as shown in Annexure-II, who have completed a minimum of 02 years stay at their present place and who requested for transfer on various grounds were examined and some of them were considered purely based on merits

The Principals of Government Junior Colleges in Zone- IV as shown in the Annexure I & II are requested to get themselves relieved from the post of Principal by handing over the complete charge to the senior most qualified & eligible regular Junior Lecturer of the College and join at the new station & report compliance. With regard to the places, where no regular Junior Lecturer is available in that College, the Principals who got transferred under liable transfers will join their new places, immediately

The District Vocational Education Officer concerned shall identify the senior most Junior Lecturer in the District and arrange F.A.C to such Colleges immediately. The D.V.E.O should also ensure that, the person who is posted to such Colleges, shall work as Principal [F.A.C] on full time basis and shall not be allowed to shuttle between his previous station where he is Junior Lecturer and the new place where he is Principal [F.A.C]. These F.A.C Principals shall also take classes compulsorily in their subject

With regard to those Principals who opted for a request transfer they will get relieved only after a substitute reports for duty.

The dates of relief and joining duty shall be reported promptly. It is further instructed that as per the instructions issued by the Government, the transferred employee is deemed to have been relieved from his/her present station at the end of seven days from the date of receipt of this order

The individuals are not entitled/eligible for any T.T.A/T.A/D.A etc, as the place of posting is issued at their request in the counseling

Any deviation in this regard will be viewed seriously

The receipt of these proceedings shall be acknowledged
